



Memorandum of Understanding Between

The President of National Pingtung University of Science and Technology and the Rector of University of Córdoba for the purpose of furthering cooperation in both education and academic research, hereby affirm their intent to promote such academic exchange as will be of mutual benefit for their respective institutions. Academic exchange is considered here to include but not be limited to:

- (1) Development of mutually beneficial academic and training programs;
- (2) Exchange of students for purpose of studying; and faculty & staff for purposes of teaching, research and extension;
- (3) Reciprocal assistance for visiting academic faculty, staff and students;
- (4) Coordination of such activities as joint research and transfer of technology;
- (5) Exchange of documentation and research materials in fields of mutual interests;
- (6) Development of Dual Degree Program.


Details of the implementation of any particular exchange resulting from this agreement shall be negotiated between the two institutions as such specific case may arise, and is subject to availability of sufficient funds.

The purpose of this agreement is to promote academic exchange and may be subject to amendment, improvement or termination, at any time, upon the agreement of both Parties. This agreement shall become effective beginning the day after receiving the signatures of the authorized representatives of both Parties.
